ARTICLES OF INCORPORATION

OF

HOLIDAY DECORATIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: Holiday Decorations, Inc.

ARTICLE II. PRINCIPAL OFFICE
