As per the phone conversation I had with your office this afternoon for my client - Applause Interiors Inc., detailed below is the reason for the late filing of the Annual Corporate Return.

The store was originally located at 10542 Wiles Road, Coral Springs, Florida. After the heavy rainstorm around the middle of March 2000, the store was completely flooded. The roof caved in and the resulting damage caused the business to cease. (Please refer to the letter from the insurance adjusters regarding this effect). The landlord refused to repair the damages to the roof, the store and the inventory. There is currently a lawsuit pending in the courts.

Consequently, a lot of records and paper work were either lost or damaged in the storm. To add insult to injury, the accountant who took care of this client could not be located as well. I just took over this account and try to put things back in order for them. The Annual Report unfortunately is one of the filings that fell between the crack.

They have eventually moved to a new location a few blocks down from the original location. They were finally able to get the mail and tried their best to get things back in order. In view of all these happenings, and the lost of both business and income, I appeal to your office to please waive the penalty. Had they proceed in the normal fashion and their previous accountant was still present, they would not have been negligent in their filings and incur this heavy penalty.
