ARTICLES OF INCORPORATION

OF

ROUNDSTONE CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is ROUNDSTONE CORPORATION. The principal office and mailing address of this corporation is 7522 Wiles Road, Suite 102, Coral Springs, Florida.

ARTICLE II

The duration of the corporation is perpetual.
