The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

EFFECTIVE ONTE

ARTICLE I.

CORPORATE NAME

The name of this corporation is Mobile Vaccines, Inc.

ARTICLE II.

ADDRESS OF CORPORATION

The address of the principal office of the Corporation, or the mailing address of the Corporation, if the principal office is not yet known, is 3210 31st Ave. SW, Naples, FL 34117.

DURATION
