ARTICLES OF INCORPORATION

ARTICLE I

NAME: The name of this corporation is

TOM'S WORK UNIFORMS, INC.

ARTICLE II

DURATION: This corporation shall have perpetual duration.

ARTICLE III

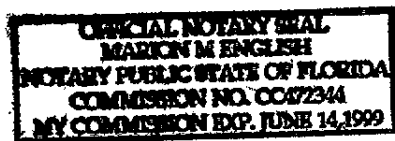


