TO

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**CORPORATE NAME:**

Effective December 30, 1999, the name of the corporation shall be:

**BayCyber.COM, Inc.**

**FIRST:** Amendments adopted:

**ARTICLE I - Offices**

Effective December 30, 1999, the principal office of the Corporation shall be located at **4218 Mill Valley Court** in the city of **Tampa**, Zip code **33624**, County of **Hillsborough** in the **State of Florida**. The registered office of the Corporation may be, but need not be, identical with the principal office, and the addresses of the principal and registered offices may be changed from time to time by the Board of Directors.

**ARTICLE V - STOCK**

Anthony G. Canizares, 4218 Mill Valley, Tampa, FL 33624

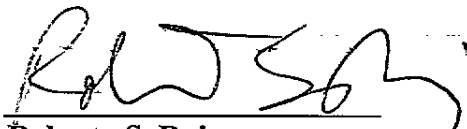

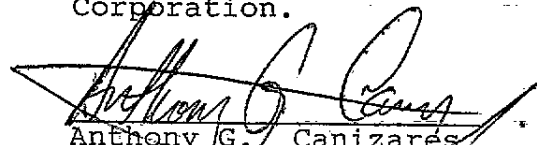

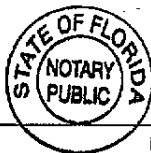
