I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **TODD E O MARKETING**, **INC.** and the initial address of this corporation shall be <u>1281 NW 78th Terrace</u>, Plantation, Florida 33322.
