**ARTICLES OF INCORPORATION
OF
BAYANIHAN VENTURES, INC.**

ARTICLE I

The name of this corporation shall be Bayanihan Ventures, Inc.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose of this corporation shall be to engage in the business of operating a restaurant to the general public and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the state of Florida.

ARTICLE IV

The amount of capital stock authorized shall be 100 shares of common stock having a par value of One Dollar (\$1.00) per share, making a total authorized capital stock of One Hundred Dollars (\$100.00).


