## ARTICLES OF INCORPORATION OF VISIONARY ASSISTED LIVING, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607, Fla. Stat., the Florida Business Corporation Act, hereby states the following:

### ARTICLE I - NAME AND ADDRESS

Section 1. The name of the Corporation shall be Visionary Assisted Living, Inc.

Section 2. The initial principal office and the initial mailing address of the Corporation shall be 130 Marina Del Rey Court, Clearwater, Florida 33767.

#### ARTICLE II - DURATION

The Corporation shall have perpetual existence beginning on the date of filing hereof with the Florida Secretary of State, Division of Corporations.

### ARTICLE III - PURPOSE AND POWERS

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

#### ARTICLE IV - CAPITAL STOCK

Section 3. Any Bylaws adopted by the Board of Directors or the stockholders may be altered, amended or repealed by the other group; provided, however, that any Bylaw adopted by the stockholders may provide that it shall be altered, amended, or repealed only by the stockholders.
