

ARTICLES OF INCORPORATION

OF

CARBONELLI, INC.

Article I - Name

The name of this corporation is CARBONELLI, INC.

Article II - Principal Place of Business

The principal place of business of this corporation is 3349 Ashwood Court, Tarpon Springs, FL 34689.

Article III - Duration
