**ARTICLES OF INCORPORATION
OF

The undersigned, acting as the sole incorporator of COFFEE CULTURE, INC. (the "Corporation"), pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$0.01 per share.
