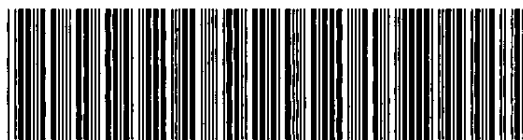

The number of votes cast by the shareholders of this Corporation for dissolution was sufficient for approval of that action.

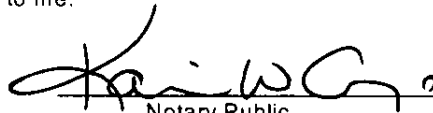
