# ARTICLES OF INCORPORATION

## ARTICLE ONE

The name of the corporation is Y2K SURVIVAL CENTER, INC.

## ARTICLE TWO

The duration of the corporation is perpetual.

## ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To provide the retail sale of year 2000 products.
2. To transact in any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

## ARTICLE FOUR

The corporation is authorized to issue Sixty (60) shares of common stock.

## ARTICLE FIVE

Every shareholder upon the sale for cash of any new stock of this corporation, of the same kind, class or series as that which he already holds, has the right to purchase his pro-rata share at the price at which it is offered to others. 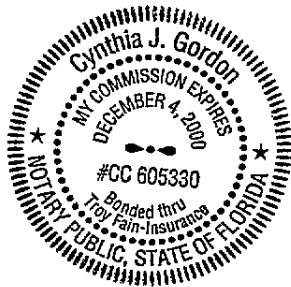
