These Article of Incorporation may be amended in the manner provided by law.


**ARTICLE X. MANAGEMENT BY SHAREHOLDERS**

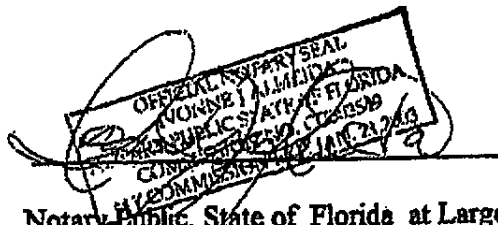
