

The undersigned incorporator, being a person competent to contract subscribes to these Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

ARTICLE I

Name

Business and Activities

This corporation shall engage in real estate sales & consulting. In addition, this corporation may and is authorized to engage in any activity of business permitted under the laws of the United States and of the State of Florida.
