**ARTICLES OF INCORPORATION FOR
FLORIDA BUSINESS UNIVERSITY, INC.**

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation.

ARTICLE I

The name of the corporation is FLORIDA BUSINESS UNIVERSITY, INC.

ARTICLE II

The existence of the corporation shall begin upon filing of these documents. Existence shall be perpetual until dissolution pursuant to Florida Statutes.

ARTICLE III

The address of the principal office of the corporation is 499 State Road 434, Suite 1075, Altamonte Springs, Florida 32714.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one (1) vote for each share upon all matters on which shareholders have the right to vote.

The corporation shall indemnify its Directors, Officers, Employees, and Agents to the fullest extent permitted by law.

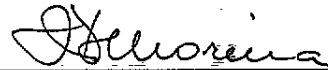
