

Articles of Incorporation Of Judy's Cleaning Service, Inc.

The undersigned, acting as incorporators of a corporation (hereinafter referred to as the "corporation") under provisions of the Florida Business Corporation Act, as amended from time to time, adopts the following Articles of Incorporation:

ARTICLE I. The name of the corporation is **Judy's Cleaning Service, Inc.**

ARTICLE II. The initial post office address of the principal office of this corporation in the State of Florida is 4989 E. State Road 44, Lot 7, Wildwood, Florida 34785. The street address of the corporation is the same.

ARTICLE III. The general purposes for which this corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.




