The name of the corporation shall be A ABSOLUTE PROTECTION, INC.

ARTICLE II

ARTICLE X


The corporation reserves the right to amend or repeal any provisions contained in these articles, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

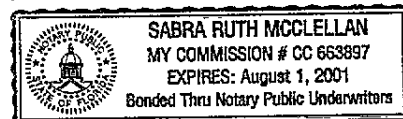

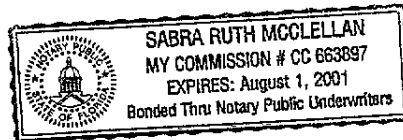
