THE UNDERSIGNED, acting as sole incorporator of JCJ of Orlando, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is JCJ of Orlando, Inc.

**ARTICLE II
SHARES**

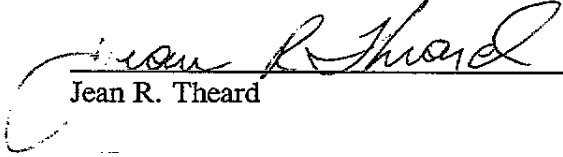
