**ARTICLES OF INCORPORATION  
OF  
GCC BEACON 22, 23 & 24, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Company") is GCC Beacon 22, 23 & 24, Inc.

**ARTICLE II**

The existence of the Company shall begin on the date of acknowledgment of these articles of incorporation.

**ARTICLE III**

The street address of the principal office of the Company is 1650 Prudential Drive, Suite 400, Jacksonville, Florida 32207.

**ARTICLE IV**

The maximum number of shares this Company is authorized to issue is 10,000, all of which shall be Common Shares. 
## ARTICLE VII
