The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be F V C CORPORATION

#### ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on March 8, 1999 and shall exist perpetually unless sooner dissolved according to law.

#### ARTICLE III - ADDRESS

#### ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:
