ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be F V C CORPORATION

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on March 8, 1999 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

The mailing address of the corporation is 8851 N.W. 119th Street, Apt. #1212, Hialeah Gardens, FL 33018.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

500	Common	\$1.00

Subject to applicable Florida Statutes, every Shareholder, upon the sale of any new stock of the corporation of the same kind, class or series as he or she already holds, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered by others.

ARTICLE V - REGISTERED AGENT

The name and address of the Registered Agent of the corporation is Jorge E. Cabrera, 8851 N.W. 119th Street, Apt. #1212, Hialeah Gardens, FL 33018.

ARTICLE VII - BOARD OF DIRECTORS

The corporation shall have two directors initially. The number of directors may be increased or decreased from time to time thereafter in accordance with the bylaws of the corporation but shall never be less than one. 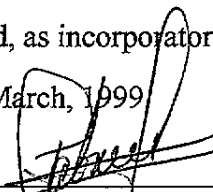
ARTICLE VIII - SHAREHOLDER PROPERTY

The shareholders shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.

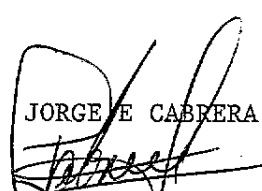
