ARTICLES OF INCORPORATION

The undersigned for ourselves our associates successors and assigns hereby associates ourselves together for the purpose of forming a corporation under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunity of a corporation for profit hereby certify:

ARTICLE I

ARTICLE VI

This corporation is organized to provide handyman services to the general public as well as businesses and all other related support services.

The corporation is also organized to engage in any business activities and for any and all other purpose permitted under the laws of the United States, The State of Florida and any other State in which the corporation is or shall be authorized to conduct business.

In this country or in any foreign country to the extent that said purposes are not forbidden by the laws thereof subject to specific written limitations or restrictions imposed by law or otherwise by these Articles of Incorporation and solely in furtherance of, but not in addition to the purposes herein above set forth to have and exercise all of the powers as are or may from time to time be inferred by statute or otherwise.
