ARTICLES OF INCORPORATION OF

GULF COAST FLOOR AND WALL, INC.



I. NAME

The name of the corporation is GULF COAST FLOOR AND WALL, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

III. NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the Laws of the State of Florida.
