

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following amendments to its Articles of Incorporation:

ARTICLE I: The name of the corporation (which may sometimes hereafter be referred to as the "Corporation") is changed to


BKRY of Florida, Inc.

The principal office of the Corporation shall be 1200 South Pine Island Road, Plantation, Florida 33324, with the privilege of having its offices at other places within or without the State of Florida, and the registered agent for the Corporation shall be CT Corporation System, 1200 South Pine Island Road, Plantation, Florida 33324.

The amendments were adopted on February 10, 2004 and shall be effective upon the filing of these Articles of Amendment.
