# ARTICLES OF INCORPORATION

OF

### SIMPLICITY HOLDING CORPORATION

The undersigned subscriber to these Articles Of Incorporation
hereby subscribes to and forms a corporation for profit under the
laws of the State of Florida.

#### ARTICLE I - NAME
