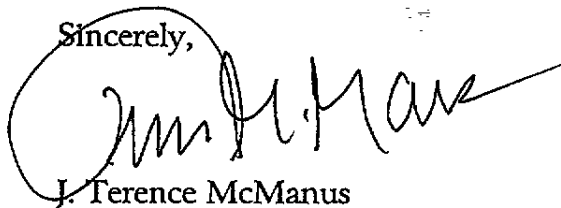

The name of the corporation is R. Monaco Enterprises, Inc.

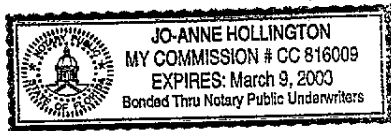
