
To Whom It May Concern:

Florida state electric did not renew Corporation because of the death in the partnership and professional license holder of the Corporation. A new Corporation AGT Electrical Contractors Inc. was formed with a new partners and license holders.

On trying to collect the receivables for Florida state electric inc. the court system, Judge requested that we reinstate the Corporation for the purpose of collecting the receivables owed to the Corporation.
