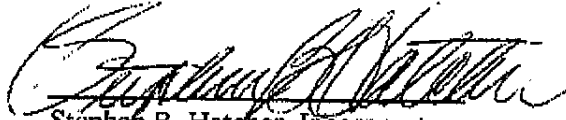
ARTICLE VI
