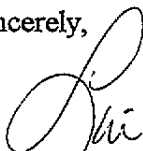

The undersigned incorporator hereby forms a corporation under Chapter 607, Florida Statutes, as follows:

Article I-Name

The name of the corporation shall be All-Pro Stucco & Plastering, Inc., and the principal office and the mailing address of the corporation shall be 636 96th Avenue North, Naples, FL 34108.

Article II-Nature of Business

The corporation is authorized to conduct any activities as are permitted under applicable Florida Statutes.

Article III-Capital Stock

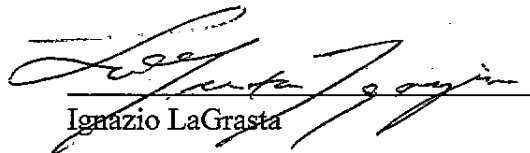

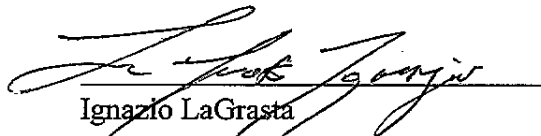
