EXPLANATORY STATEMENT

These Amended and Restated Articles of Incorporation of All-Pro Stucco & Plastering, Inc., a Florida corporation (the "Corporation"), are executed and filed in accordance with Section 607.1007, Florida Statutes. This is an amendment and restatement of the Articles of Incorporation of the Corporation originally filed with the Florida Department of State on March 25, 1999 and assigned document number P99000029002.
