ARTICLE I – NAME

The name of this corporation is DAHER CONTRACTING, INC.

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

The street address and mailing address of the principal office is 4507 Boca Drive, Niceville, FL 32578.

ARTICLE III– DURATION

This corporation shall have a perpetual existence commencing on the date of signing of the Articles of Incorporation. Effective Date: March 22, 1999.

ARTICLE IV– PURPOSE

This corporation is organized for the purpose of the contracting and for transacting any or all lawful business as allowed under the laws of Florida.

ARTICLE V – CAPITAL STOCK

This corporation is authorized to issue 1,500,000 shares of One Cent (\$0.01) par value common stock, which shall be designated "common shares".

ARTICLE IX – BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X – AMENDMENT

This corporation reserves the right to amend or repeal any amendment hereto, and any right, conferred upon the shareholders is subject to reservation.
