## ARTICLES OF INCORPORATION OF La VIGNA RESTAURANT, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is La VIGNA

RESTAURANT, INC.

ARTICLE II - DURATION. This Corporation shall have perpetual existence unless dissolved according to law.
