The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Florida Statute, Chapter 607, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME

ARTICLE VII- NATURE OF BUSINESS

ARTICLE VII- GENERAL POWERS

The Corporation shall have full power and lawful authority to issue, execute, assign and endorse notes, mortgages, bonds, and all other negotiable papers to hold, bind, and sell stock of
