# ARTICLES OF INCORPORATION

OF

BRANDT BUILDING MAINTENANCE AND FAST FOOD EQUIP. SERVIČE INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

## ARTICLE I

EFFECTIVE DATE

# Name and Business Address

Section 1.1 Name. The name of the corporation is **BRANDT BUILDING MAINTENANCE AND FAST FOOD EQUIP. SERVICE INC.** The business address of the corporation is PO BOX 26828, Jacksonville, FL 32226

#### ARTICLE II

#### Duration

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledge, except that if they are not filed by the Department of State of Florida within five (5) days, exclusive of legal holidays. After they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

#### ARTICLE III

#### **Purposes**

Section 3.1. Purposes. This Corporation is organized for the purpose of transaction any or all lawful business permitted under the Laws of the United States and of the State of Florida. Specifically practicing fast food equip. maint. and repair.

#### ARTICLE IV

#### Capital Stock

Section 4.1. Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.

- Section 4.2. Restrictions on Transfer of Stock. The Shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
- Section 4.3. Approval of Shareholders Required for Merger. The approval of two-thirds of the outstanding shares of this corporation to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
- Section 4.4. Preemptive Rights. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE V

## **Initial Registered Office and Agent**
