IV. REGISTERED OFFICE



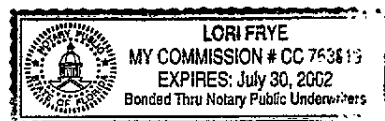
