The name of the corporation is COBRA INSURANCE, INC.

All shareholders of the corporation shall be vested with full pre-emptive rights.

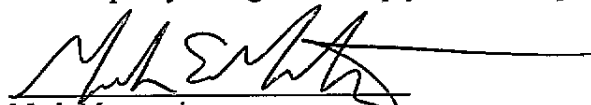
