## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF OUTONTHENET.COM, INC.

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The current name of the corporation is **OUTONTHENET.COM** (the "Corporation") filed on March 31, 1999, with the State of Florida Department of State, Document number P99000029411.
- 2. The following Amendment to the Articles of Incorporation was adopted by written consent of the shareholders of the Corporation effective as of August 30, 1999 following approval by written consent of all of the Directors of the Corporation effective as of August 30, 1999, in the manner prescribed by §607.1003 of the Florida Business Corporation Act:

**RESOLVED**, that the second sentence of Article I of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:

**RESOLVED**, that Article III of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:

## ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have the authority to issue is one hundred million (100,000,000) shares of common stock, all of which are to have a par value of \$.001. Authorized capital stock may be paid for in cash, services, property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

**RESOLVED**, that Article IX of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:

## ARTICLE IX INDEMNIFICATION

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

**RESOLVED**, that Article XI of the Corporation's Articles of Incorporation shall be deleted in its entirety.

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same
