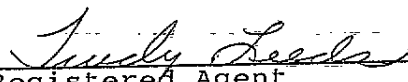

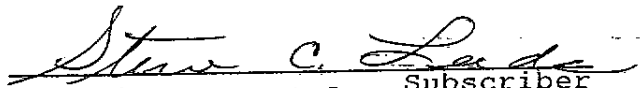
ARTICLE X - INDEMNIFICATION

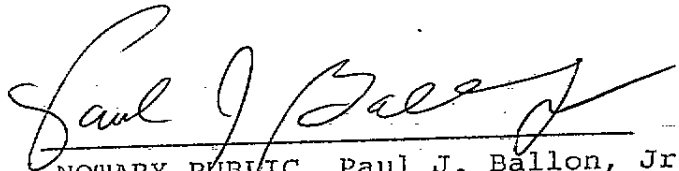

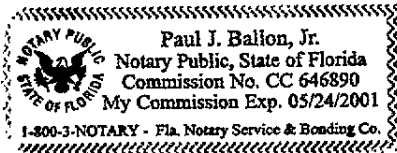
