ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Zindigo Productions, Inc. The principal office of the Corporation and the mailing address of the Corporation is 2404 Coral Ridge Circle, Melbourne, Florida 32935.

Article 2. Duration. The duration of the Corporation is perpetual.

- Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.


