ARTICLES OF INCORPORATION
OF
HOTEL CO-OP, INC.

ARTICLE I - NAME

The name of this corporation is Hotel Co-op, Inc.

ARTICLE II - ADDRESS

The address of the corporation is 696 N. Maitland Avenue, Maitland, Florida 32751.

ARTICLE III - DURATION

This corporation shall exist indefinitely.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue One Hundred Thousand 100,000 shares of \$0.01 par value common stock.


