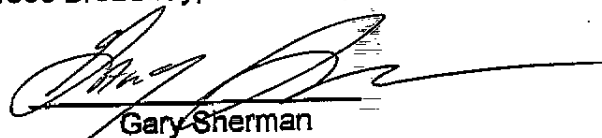
THIRD: The number of shares the corporation is authorized to issue is: One thousand (1,000) without par value.

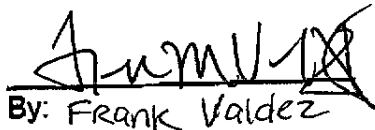
