Article I be and it is amended to read as follows:


"The name of this corporation shall be MEDICAL PRACTICE SOLUTION SERVICES, INC."

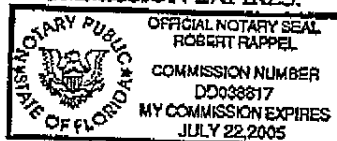
