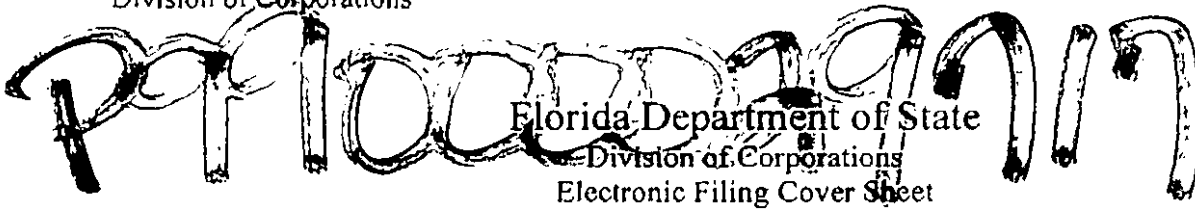


This Notice of Corporate Dissolution is being submitted by Agora USA, Inc., a Florida corporation (the "Corporation"), for resolution or payment of any and all unknown claims against the Corporation pursuant to Section 607.1407, Florida Statutes.
