Name

The name of the corporation is ECL, INC.

ARTICLE II

Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 30th day of MARCH, 1999.

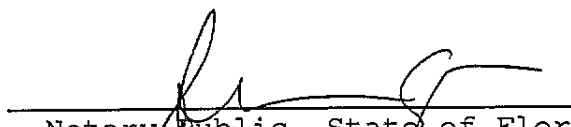

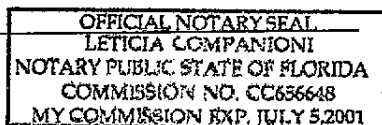
