Article 1
Name

The name of the corporation is **CALL ONE TECHNICAL SERVICES, INC.**



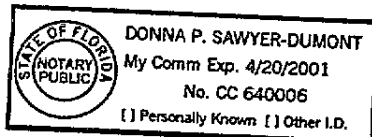
