Every shareholder, upon the sale for cash of any new stock shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

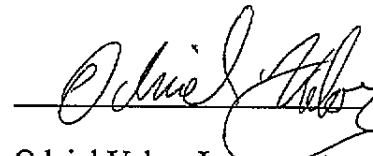
ARTICLE 9-INDEMNIFICATION

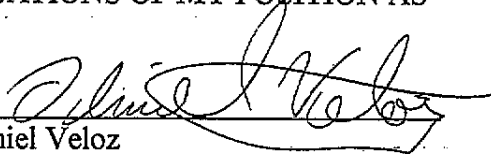
