

Pursuant to the provisions of the Professional Service Corporation Act of the State of Florida, the undersigned, FRANCIS W. BLANKNER, being a duly licensed attorney at law, does hereby make, organize and form a professional service corporation under the following Articles of Incorporation, to-wit:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be FRANCIS W. BLANKNER, P.A.

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To render professional service to the public as an attorney at law, duly licensed under the laws of the State of Florida in accordance with the terms and provisions of the Professional Service Corporation Act of the State of Florida.

In addition to the foregoing powers, this corporation shall have all of the general and additional powers and authority granted to professional service corporations under the laws of the State of Florida.
