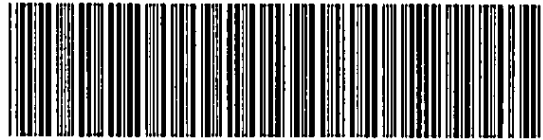

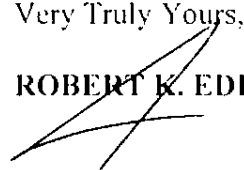

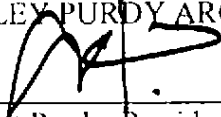
**ARTICLE I**
