The following plan of merger is submitted in compliance with Section 607.1104, Florida Statutes.

- 3. SBA Senior Finance II LLC, a Florida limited liability company owns one hundred percent (100%) of the issued and outstanding capital stock of the surviving corporation. The surviving corporation owns 100% of the stock of the merging corporation.
- 4. On the effective date of the merger, each of the issued and outstanding shares of common stock of the merging corporation, and all rights in respect thereof, shall be canceled.
- 5. Other provisions relating to the merger are as follows:
- (A) Assumption of Assets. All property, rights, privileges, powers, trademarks, licenses, registrations and other assets of every kind and description of the merging corporation shall be transferred to and vested in the surviving corporation without further act or deed, and all property (including real, personal and intellectual) of the merging corporation shall be the property of the surviving corporation.
- (B) <u>Assumption of Obligations</u>. All obligations of the merging corporation shall become obligations of the surviving corporation.
- (C) <u>Effective Date</u>. The merger shall become effective at 11:59 p.m. on December 31, 2007 (the "Effective Date").
- (D) <u>Board of Directors Approvals</u>. The Boards of Directors of the surviving corporation and the merging corporation have approved this Plan of Merger and the filing of the Articles of Merger and all other documents or certificates required to be filed with the Florida Department of State, each by Written Consent dated December 27, 2007.
- (E) <u>Articles of Incorporation</u>. The Articles of Incorporation shall continue to be the Articles of Incorporation of said surviving corporation until further amended and changed in accordance with the provisions of the Florida Business Corporation Act.

- (F) <u>Bylaws</u>. The Bylaws of the surviving corporation in effect currently and at and as of the Effective Date will remain the Bylaws of the surviving corporation without any modification or amendment in the merger.
- (G) <u>Officers and Directors</u>. The directors and officers of the surviving corporation shall be those persons who were the members of the Board of Directors and the officers, respectively, of the surviving corporation immediately prior to the Effective Date and shall remain the directors and officers of the surviving corporation until their successors shall have been duly elected and qualified.
- (H) <u>Required Actions</u>. SBA Network Services, Inc. shall take, or cause to be taken, all action required or advisable under the laws of the State of Florida to consummate and make effective the intent of this Plan of Merger.
- (I) <u>Dissenters' Rights</u>. Because the merging corporation has one shareholder, there will not be dissenters' rights in connection with the merger.
